

A Memorandum of Understanding (MoU) Between the Government of Malaysia, through the DOSM and The Statistical, Economic and Social Research and Training Centre for Islamic Countries (SESRIC) was signed on March 5, 2020 at the Permanent Mission of the United Nations (UN) to the New York successfully.

It aims to foster "Co-Operation in the Field of Statistical Capacity Development to Strengthen the National Statistics Systems (NSS) of the Organisation of Islamic Cooperation (OIC) Member Countries".

Chief Statistician Malaysia signed MoU representing Malaysia meanwhile SESRIC was represented by His Excellency Mr. Nebil Dabur, Director General Of SESRIC. ADB ASIAN DEVELOPMENT BANK

Regional: 2020 International Comparison Program for Asia and the Pacific

As the Regional Implementing Agency (RIA) of the International Comparison Program (ICP) for Asia and the Pacific since 2003, the Asian Development Bank (ADB) has successfully coordinated the 2005 and 2011 ICP benchmark rounds and produced regional comparable PPPs required to estimate the global PPPs. To continue the role of the RIA for ICP, ADB approved the Knowledge and Support Technical Assistance (KSTA) in 2020. The 2020 ICP cycle is implemented in accordance with the UNSC decision to make ICP a permanent element of the global statistical work program by conducting ICP every three years beginning with the 2017 cycle.
