18th Session of the Governing Council of the Statistical Institute for Asia and The Pacific (GC SIAP)

GOVERNING COUNCIL (GC)

- Established in April 1995 under SIAP.
- The members consist of a representative designated by the Government of Japan and eight (8) representatives nominated by other members and associate members of ESCAP elected by the
- The membership term is for three (3) years, but eligible for re-election.
- SIAP is the Secretary of the Council.
- The Council will meet at least once a year and adopt its own rules of procedure.
- The Executive Secretary of ESCAP or his/her representative will attend meetings of the Council.
- The Council shall, at each regular session, elect a Chairperson and Vice-Chairperson, who shall hold office until the next regular session of the Council.
- Responsible to:
 - review the administration and financial status of the Institute and the implementation of its programme of work.
 - review and endorse annual and long-term work plans consistent with the
 - submit an annual report, as adopted by the Council will be submitted to the Commission at its annual sessions.

The member countries of Asia and the Pacific voted overwhelmingly in favour of malaysia.












18th Session of the Governing Council of the Statistical Institute for Asia and The Pacific (GC SIAP) (Cont...)



In addition, Malaysia has also been trusted to chair the 18th Session of GC SIAP which was held in Chiba, Japan.

Malaysia is nominated by India and the Republic of Korea and supported by the Philippines.

The 18th Session concludes the meeting with the following decision:

- Training must be designed with training needs in mind that vary by country and depend on facilities.
- Diversify training modalities depending on the topic and resources, such as e-learning, face-to-face, and hybrid training.
- Stressed the need for online courses in languages other than English.
- Enhanced the training on communication, user-friendly outputs, and statistical literacy based on existing available resources to overcome the NSO challenges in disseminating data to the public, decision-makers, media, and other users.
- Develop the Training of Trainers (ToT) workshop that includes information on how to train for e-learning and develop interactive e-learning content to train staff to be trainers.
- Realised the importance of long-term training course evaluation.
- Emphasised using practical examples in courses and sharing best practices among NSOs through improved south-south collaboration to make training relevant and applicable.
- Endorsed the Work Programme and Financial Plan of the Institute for the year 2023.

DOSM's Commitment

As a member, under the capacity of the Malaysia Statistical Training Institute (ILSM), DOSM has expressed its readiness to organise SIAP regional courses and seminars in collaboration with SIAP and ESCAP in the future.

DOSM will also continue to actively participate in courses organised by SIAP and be prepared to provide technical assistance or experts in the field of statistics.











The 8th Network for the Coordination of Statistical Training in Asia and the Pacific (the Network)

THE NETWORK

- SIAP is the secretariat of the Network for the Coordination of Statistical Training in Asia and the Pacific, which was created in September 2013 on the recommendation of the Committee on Statistics of ESCAP to facilitate the coordination of statistical training in the region.
- Members of the Network are 13 countries and 13 international organisations.
- · The Network has identified the following priority areas:
 - Coordination. includina development of common training programmes in response to the requirements of key regional statistics development programmes;
 - Share information on the work of statistical training providers, to facilitate cooperation among the providers and relevant stakeholders; and
 - Periodically review the implementation of the proposed coordination activities, and identify and implement further actions required.

8th Network discussed on:

Session I: Report from the subgroup on gender statistics <u>training</u>

A representative of UN Women provided a comprehensive explanation of gender statistics training at the meeting. The course svllabus has been made available online, and efforts are being made to organise the course through the formation of a ToT amona relevant members.

Session 2: Training modalities post COVID-19 pandemic

The Economic Statistics Sub-group reports that the economic statistics training package has been coordinated with related SIAP courses, including the ToT course. In addition, the meeting was informed that the sub-group on Environment & Agriculture Statistics and Disaster Statistics has been discontinued and all training materials related to the subgroup are available on the SIAP website.

Session 3: Looking ahead - review of the functioning of the Network

The meeting also addressed the overlap of functions between the Network Group and the Global Network of Institutions for Statistical Training (GIST), whose driving force consists of personnel from SIAP and ESCAP. It is difficult for the Network & GIST to carry out the activities it has planned due to contributors' allocation restrictions. Despite this, the expertise possessed by personnel in the two groups is a valuable asset to SIAP and ESCAP's efforts to boost capacity and course organisation.











17th Management Seminar for the Heads of National Statistical Offices (NSOs) in Asia and the Pacific

Theme: Managing Evolving Data Ecosystems-Governance, Stewardship and Changing Roles of the NSOs

Overview and Aspirations

The overarching goal of the management seminar is to improve statistical capability in leadership and management for the Heads of National development. It is intended to create a forum in which heads of NSOs can identify, discuss, share valuable insight and propose joint solutions for dealing with the rapidly changing environment in which they operate.

"Managing Evolving Data Ecosystems: Governance, Stewardship, and the Changing Roles of the NSOs" was the focus of this year's Management Seminar. Insights and country experiences were shared by participants from around the world on data governance and data stewardship, allowing for the identification of best practices and doable long- and medium-term approaches that can be adopted by NSOs as well as aiding SIAP in terms of developing training, knowledge sharing or additional guidance on the matter.

The seminar modality was transformed into new approaches by encouraging all countries to contribute, speak and share experiences in a series of round table discussions (breakout groups) that began with a keynote presentation on a broad theme, followed by the discussion of six topics as follows:







Session 1: National Data Strategy - Data Ecosystem, Governance and Stewardship (Plenary)

DOSM Contributions

Throughout the session, DOSM shared its experience with the effort taken to emerge as the central agency in Malaysia responsible for data stewardship and data governance. Among others, DOSM's action in the amendment of the Malaysia Statistical Acts 1965, the establishment of the Chief Data Officers (CDO) at all government agencies at the federal and state levels, the National Statistics and Data Council (MSDN), the National Big Data Analytic Center (NBDAC) and the State/Regional Statistics and Data Council (MSDNgW) received overwhelming encouragement and support from the member states of the Asia Pacific region.

During the seminar, Malaysia highlighted the significance of social media in disseminating statistics to the public. In addition, using interactive dashboards and data portals to publish statistics has also become a priority for Malaysia to reach the users of the statistics. Professor Paul Cheung, former Director of UNSD, expressed his enthusiasm for DOSM's initiatives and achievements in advancing statistics at the national and international levels. The member nations anticipate that Malaysia's approach to data governance and stewardship will serve as the industry standard for NSOs in the Asia and Pacific region, serving as a model for national-level NSOs.

Malaysia was voted in as a member of the Governing Council of the Statistical Institute for Asia and the Pacific (GC SIAP) for the term 2022 – 2024

PUTRAJAYA, May 27, 2022 – Malaysia has been given the honour to be a member to the Governing Council of the Statistical Institute for Asia and the Pacific (GC SIAP) for the term 2022 – 2024, following elections held during the seventy-eighth session of the Economic and Social Commission for Asia and the Pacific (ESCAP) on 24th May 2022 in Bangkok. Malaysia received overwhelming votes from member countries of Asia and the Pacific.

SIAP is a professional statistical training center for government officials from developing countries operated since 1970 and granted as the regional institution of ESCAP with the establishment of the Governing Council (GC) in 1995, located in Chiba city, Japan. It has been assisting developing countries in their human resource development through training officials in the Asia and Pacific region and also in other areas of the World. The GC aims to review the operations and endorse the annual and long-term programmes of work of the Institute consisting of a representative of the Government of Japan and eight representatives nominated by other members and associate members of ESCAP elected by the Commission. In addition to the host country (Japan), the current elected members of the Governing Council are Bangladesh, China, India, Malaysia, Philippines, Republic of Korea, Thailand dan Viet Nam.

Malaysia has been elected as the Chair of the Governing Council of the Statistical Institute of Asia and the Pacific (GC SIAP) for the Eighteenth Session in 2022

PUTRAJAYA, DECEMBER 12, 2022 – Malaysia is honoured to be elected Chair of the 18th Session of the Governing Council (GC) of the Statistical Institute for Asia and the Pacific (SIAP) held in Chiba, Japan from 12th – 13th December 2022. Malaysia through the Department of Statistics Malaysia (DOSM) is represented by Chief Statistician, YBhg. Dato' Sri Dr. Mohd Uzir Mahidin and Mr. Zuraidy Zainal Abidin, Director of Malaysia Statistics Training Institute (ILSM).

After ten (10) years joined as an observer, Malaysia was elected to the GC SIAP as a member for the term 2022-2024 during the Seventy-Eighth Session of the Economic and Social Commission for Asia and the Pacific (ESCAP) on 24th May 2022 in Bangkok. Malaysia received overwhelming votes from member countries of Asia and the Pacific.

SIAP is a professional statistical training center in Chiba, Japan that has been operating since 1970 and was granted ESCAP regional institution status with the formation of the GC in 1995. The Council is made up of a representative from the Japanese government and eight representatives elected by other members and associate members of ESCAP. Aside from the host country (Japan), the current elected members of the Council are Bangladesh, China, India, Malaysia, the Philippines, the Republic of Korea, Thailand and Viet Nam. It has aided developing countries in their human resource development by training officials in the Asia-Pacific region and other parts of the world. The Council's goal is to review the Institute's operations and approve its annual and long-term work plans.

The 18th session will discuss matters regarding the provision of training according to the needs of different member states, including matters arising from the Seventeenth Session of the Governing Council; new challenges related to training; the Director's report on his achievements in 2022; and the proposed work plan for 2023.

In his Chairmanship Statement, Dr. Uzir stated, "I sincerely hope that we can create a welcoming environment as well as provide the leadership and experience required to continue the important work of this council over the next three years. Malaysia will continue to work with the entire team of the Asia and Pacific statistical community to expand statistical capacity-building programmes and activities to assist Member States in improving the quality and availability of statistics, particularly in implementing and
